CODE OF ETHICS FOR FANA BOARD OF DIRECTORS & MEMBERS

<u>Goal</u>: To establish a set of principles and practices of Fiji American National Association, further known as "FANA" Board of Directors that will set parameters and provide guidance and direction for conduct and decision-making.

<u>Code</u>: Members of the Board of Directors of the FANA are committed to observing and promoting the highest standards of ethical conduct in the performance of their responsibilities on the Board of FANA. Members pledge to accept this code as a minimum guideline for ethical conduct and shall:

Accountability

- 1. Faithfully abide by the Articles of Incorporation, by-laws and policies of FANA.
- 2. Exercise reasonable care, good faith and respect and due diligence in organizational matters/activities.
- 3. Participate actively in Board meetings and actions.
- 4. Fully disclose, at the earliest opportunity, any actual conflict of interest between my personal life and my position on the Board and abstain from voting when appropriate.

Professional Excellence:

5. Maintain a professional level of courtesy, respect, and objectivity in all FANA activities.
